Whereas, the undersigned realizes that shooting, hunting and outdoor recreation are inherently dangerous activities, which carry the risk of personal or bodily injury and damage to property.

NOW, THEREFORE, in consideration of permission to participate in shooting, hunting and other recreational activities on or in connection with the lands owned, leased, and/or controlled by James Nuzzi, Asima Inc., American Whitetail LTD LLC, and Falling Leaf Outfitters LLC, the undersigned, on his behalf (and if applicable, on behalf of his minor children or dependents) and, on behalf of their respective heirs, executors, administrators and assigns hereby releases and forever discharges James Nuzzi, Asima Inc.(and it's officers), American Whitetail LTD LLC and Falling Leaf Outfitters LLC, their heirs, administrators, executors, partners, associates, family members, family corporations, and assigns from any and all claims, demands, actions, causes of action, costs or expenses of any kind whatsoever, arising from or by reason of any bodily injury or personal injury, known or unknown, or death, or property damage, resulting from or arising out of participation by the undersigned (and if applicable, his minor children or dependents) in shooting, hunting and other recreational activities on or in connection with lands owned, leased and/or controlled by James Nuzzi, Asima Inc., American Whitetail LTD LLC and Falling Leaf Outfitters LLC. This release contains the entire agreement between the parties and the terms of this release are contractual and not a mere recital. I understand that all deposits made for seasonal memberships, guided hunts or any products or services provided by American Whitetail LTD, LLC and/or Falling Leaf Outfitters LLC, are completely non-refundable.

I have carefully read the foregoing Release and I full understand its contents.
